Australian EP Experience

In early 2011, the Commonwealth Government committed to expand the role of the National Offshore Petroleum Safety Authority (NOPSA) to include integrity and environment management to become the National Offshore Petroleum Safety and Environment Management Authority (NOPSEMA). Since 1 January 2012, the change in the regulatory process has proved a significant challenge to the offshore oil and gas industry in relation to environmental management and compliance of all petroleum related activities.
